ORDINANCE NO. 10-2043

AN ORDINANCE AMENDING THE MOUNT JOY BOROUGH ZONING ORDINANCE BY CHANGING THE ZONING CLASSIFICATION OF TRACTS OF LAND IDENTIFIED AS 14, 18, 19, AND 20 NORTH MARKET STREET CONTAINING A TOTAL OF 2.05 ACRES, MORE OR LESS, IN THE BOROUGH OF MOUNT JOY, LANCASTER COUNTY, PENNSYLVANIA, FROM CBD-COMMERCIAL BUSINESS DISTRICT TO LI-LIGHT INDUSTRIAL DISTRICT AND AMENDING THE BOROUGH ZONING MAP ACCORDINGLY.

WHEREAS, a Petition has been filed with the Borough Council of the Borough of Mount Joy, Lancaster County, Pennsylvania by KN Farms, LP, requesting a change in the zoning classification of the Property, comprised of five Lancaster County Tax Account Nos., 450-13216-0-0000, 4550-14261-0-0000, 450-15097-0-0000, 450-16044-0-00000, and 450-73764-0-0000, also being identified as 14 North Market Street, 18 North Market Street, 19 North Market Street, and 20 North Market Street, from CBD-Commercial Business District to LI-Light Industrial District; and

WHEREAS, it is deemed to be in the best interest of the public health, safety, and general welfare to amend the zoning classification of said premises.

NOW, THEREFORE, be and it is hereby ordained and enacted by Borough Council of Mount Joy Borough, Lancaster County, Pennsylvania, as follows:

Section 1. The Mount Joy Borough Zoning Ordinance is hereby amended by changing the zoning classification of a 2.05 acres of land, more or less, identified as 14 North Market Street, 18 North Market Street, 19 North Market Street, and 20 North Market Street, as more fully described in Exhibit "A" and as shown on the Plan marked Exhibit B, both attached hereto and hereby incorporated by reference into this Ordinance, from its present classification as CBD-Commercial Business District to LI-Light Industrial District.

Section 2. The Secretary of the Borough is directed to change, and duly certify, the Mount Joy Borough Zoning Map so as to effect the reclassification of the tract of land described in Exhibit A and as shown on Exhibit B from CBD-Commercial Business District to LI-Light Industrial District.

<u>Section 3.</u> All other sections, parts and provisions of the Mount Joy Borough Zoning Ordinance shall remain in full force and effect as previously enacted and amended.

Section 4. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of Borough Council that the remainder of the Ordinance shall be and shall remain in full force and effect.

Average Number of Responding Personnel per Hour for Date Range





Total Calls by Day of the Week





Total Calls by Hour








Total Calls by Day of the Week





General Fund - Our over-all revenues are at 95.66% and our over-all expenses are at 84.65%. The annual transfers between funds have been completed. I removed the CARES and ARPA line items, both Revenue and Expenses to reflect a clearer picture of how our budget for 2022 looks.

Refuse Fund - I have provided a Refuse Fund Budget report. Our over-all revenues are at 100.43% and our over-all expenses are at 87.34%. Again, annual transfers have been made.

Capital Fund – I have provided an account detail of the Capital Fund. For those asking what was spent from Capital toward different projects so far this year, this shows everything.

I continue to work on the Budget, estimating projections, analyzing reports, and updating worksheets in preparation for the 2023 numbers.

RE: Manager's Report

1. I have processed five (5) Right-To-Know Requests so far for the month of October

- 2. I have attended the Council Meeting, Public Works Committee Meeting, Public Safety Committee Meeting, Building Ad Hoc Committee Meeting, and the Chamber of Commerce Meeting. I also attended various video conference meetings throughout the month.
- 3. Reference to the **Ground Ambulance Service Agreement** with PSH Life Lion LLC, no updates.
- 4. Community Guide/Map has been sent to the printer.
- 5. Reference to <u>BMP 107/Melhorn Basin</u>, Meeting was held on October 26, 2022. Melhorn representatives have indicated that they had taken some preliminary measurements showing that they are not far off from the original as built plans. They also commented about silt and vegetation build-up at the unnamed tributary that leads to the AMTRAKs pipe under the railroad tracks. (see item 6 below) We went on site and observed the issues that Melhorns showed picture of how this area backs-up and floods their retention pond. Outcome is that Melhorn was asked to have their engineer complete measure ments to determine compliance with original plans. Borough will work towards resolution with AMTRAK.
- 6. <u>AMTRAK</u>-. I had a meeting scheduled with AMTRAK on 10/25 reference to 2 of their underground pipes and some washouts along Sassafras Alley and a bridge structure. Cody, Dennis and I waited but the representative failed to shoe. I will be following up on this.
- 7. Reference to BMP 125/Borough Basin. Kinsley complete punch list, waiting on vegetation.
- 8. Reference to **Brady's Alley**, No updates.
- 9. Building Ad Hoc Committee At the Ad Hoc Committee's monthly meeting, there was continued discussion on relocating the facility to the northeast corner of Grandview Park or Lot 1, however, the discussion was towards turning the building so that the police wing runs north & south and that the Borough/Borough Authority runs east and west. There was also discussion as to what money had been budgeted for this year and what was the motion on how to spend the monies. (Note: \$360,000 was added to the capital budget for the new facility but I have asked Ms Frey to determine if there were any monies in the line item prior to moving \$360,000 to it. Additionally, the motion was to use the funding for both schematic drawing phase and design phase.)
- 10. <u>Train Station Deed/Parking</u>. PennDOT attorney has had communication with the Borough Solicitor. I also reviewed a document and found some issues. Solicitor responded to PennDOT with noted discrepancies
- 11. Rt 772 Re-Route No updates
- 12. Grants
 - a. **DCED Multimodal Transportation Fund Grant** I was able to obtain the second and final easement for the pedestrian yield signs w/RRFB. These were forwarded to Josele who recorded them as required. Additionally, ARRO has applied for the HOP, and we are waiting on PennDOT for this. The next step following receiving the HOP with be to put the project out for bid. No additional updates.

- b. <u>Smart Growth Transportation Grant</u> We have been waiting for final payment for several months. Our contact at PennDOT has not responded to my requests via phone call or email. I will continue to work on getting final payment. I've started another round of communications with PennDOT's Project Manager having sent her an email and invoice last month. No updates at this time.
- c. <u>902 Recycling Grant</u> Public Works has initiated the purchase of equipment and a major piece of equipment has been purchased and is in-service at the compost site.
- d. <u>DCED/DCNR C2P2 Grant</u>- We received notification on April 6, 2022, that we have been awarded this grant. These funds are to be used for the Master Plan for Little Chiques Park and will be available at the beginning of 2023.
- e. NFWF 2022 Grant- Submitted
- f. Kunkle Field/Park Heritage Grant Received official word that we have received this grant in the amount of \$650,000.00 to make upgrades to Borough Park/Kunkle Field. I have started to complete necessary paperwork. This grant is unusual in that our local legislators and their staff assisted us in obtaining this grant. I am in the process of completing all the paperwork associated with the project. No additional information at this time.
- g. Watershed Restoration Grant- Submitted
- h. Growing Greener Grant Submitted
- i. RACP Grant Submitted. I will note that during the application process I had contacted the state staff for assistance on one of the questions. At that time, I was advised that we still had \$2,483,000.00 approved for building the new facility. In essence then, we are requesting the additional \$2,339,112.00 which, if awarded, will bring us to the maximum of RACP allowance of 50%. Any and all future funding for the new facility will require that the funds are able to be used for the Borough's 50% match.
- 13. Schatz v. Borough of Mount Joy. I provided 2 boxes of documents for the insurance attorney to review and copy those that are pertinent to the law suite to provide to the plaintiff's attorney. Per the attorney, Plaintiff's attorney has not supplied any documents that the insurance company has requested.
- 14. **SHENTEL** I had forwarded the documents to Josele for review in reference to initiating talks with SHENTEL/Cohen Group. She advised that they are standard documents and she saw no issues with signing them. She further related that she has been reviewing these and franchise agreements for other municipalities.
- 15. **Refuse Collection Agreement** Bods were opened on October 26,2022. Low bid was GFL, the current contractor. Solicitor is currently reviewing the documents.
- 16. <u>Compost Site</u> Received notification from Mount Joy Township that they wish to continue the practice of using the compost site.
- 17. Florin Hills Infiltration Basin "D" -LCCD is attempting to set up meeting with Charter homes.
- 18. Reference to <u>Ordinances</u>, I am still waiting on Josele to complete the language for the ordinance regarding parking permits, no truck and limited truck traffic
- 19. **<u>Budget</u>** -Review process has started with Council Budget meetings.
- 20. <u>Employee Evaluations/Appraisals</u> Appraisals completed and Admin & Finance Committee established a protocol as to how this will interact with pay raises.
- 21. <u>Codes/Zoning</u> I have received 5 applications for Codes/Zoning Administrator. We will start the interview process on Thursday, 10/27. Interviews were put on hold until I am able to return to work.
- 22. Administrative Vehicle I provided some numbers to the Admin & Finance Committee as to what local dealerships had in stock or smaller vehicle such as the Ford Escape of Chevy Equinox with mileage in the 80,000 range. Prices came in around \$15,000 to \$20,000. Committee discussed that this vehicle would be a second administrative vehicle not just for borough staff and elected officials should they be attending a meeting or training outside of the Borough. The Committee asked that I follow-up on 2 things. One, does COSTAR apply to used vehicle? Per Rick McCord at Whitmoyer Fleet Department, the answer is no. However, he mentioned that he could offer municipality a lower price than what he can do with the public. Example was a Jeep 4wd Laredo advertised at \$19,998 would be \$17,998. Second, question is can the Borough lease a vehicle (IF ONE WERE TO BE AVAILABLE). Rick indicated that a municipal lease can be done. On an Escape it would be approx. \$8,500.00 once per year for 4 years. This information was presented to Admin & Finance Committeee and I was asked to see what the cost would be for a similar vehicle on CoStars pricing.
- 23. I was able to take a <u>Certified Stormwater Inspector</u> online course administered by the National Stormwater Center. Following completion, I received a 5-year certification as a Certified Stormwater Inspector.

24. Microphones in Council Chambers – First, Dennis, Jill and I did some testing on the microphones and found 3 to be inoperative. I contacted "EdgeUp", and a serviceman came the next day. All were working at this time. He did additional testing and determined that as the batteries die, even though lights are lit, they stop broadcasting. We will be doing additional testing to decide haw to move forward. I also received a quote for hardwired microphones. We are currently testing rechargeable batteries that Councilor Youngerman provided.

This completes my report from the month of October. As always, please let me know if there are any questions or comments.

ORDINANCE NO. <u>7-2022</u> .	

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF MOUNT JOY BOROUGH, CHAPTER 130, FIREARMS AND OTHER WEAPONS, TO REVISE ADMINISTRATIVE PROVISIONS.

BE AND IT IS HEREBY ORDAINED AND ENACTED by Borough Council of the Borough of Mount Joy Township, Lancaster County, Pennsylvania, as follows:

Section 1. The Code of Ordinances of Mount Joy Borough, Chapter 130, Firearms and Other Weapons, §130-5, Violations and Penalties, shall be amended to provide as follows:

- A. Any person who shall violate any provisions of this Chapter shall be liable, upon conviction therefor, to fines and penalties of not less than \$100 nor more than \$1,000 plus costs of prosecution, including the Borough's reasonable attorneys' fees, which fines and penalties may be collected as provided by law.
- B. Any police officer may seize any firearm, gun, pistol, or other weapon used in this Chapter. Any such weapon shall be considered forfeited to the Borough. At the conclusion or disposition of prosecution brought hereunder, the Chief of Police shall dispose of or return the firearm in accordance with applicable law.

<u>Section 2.</u> All other sections, parts and provisions of the Code of Ordinances of the Borough of Mount Joy shall remain in full force and effect as previously enacted and amended.

Section 3. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of Borough Council that the remainder of the Ordinance shall be and shall remain in full force and effect.

Section 4. This Ordinance shall take effect and be in force from and after its enactment as provided by law.
