IV. ITEMS OF BUSINESS

1. Parks

A. Old Standby Park – Kiwanis MOU renewal – The Committee discussed that the Kiwanis Club prefers to only trim smaller shrubs. The item will be moved to the December PW meeting so Deering can meet with borough staff to look at specific plants to be trimmed.

2. Stormwater

A. Bruce Ave. stormwater pipe – The Committee discussed recent communication about the stormwater complaint from a Terrace Avenue resident. Councilors Ruschke and Ginder proposed the need for more research and information to determine the best options for the borough before taking any action.

3. Streets and Alleys

A. Grass strip discussion – Nissley reported that Stacie Gibbs said that compliance to the ordinance has been very good, and she suggest that the ordinance be left as it is. The Committee agreed to leave the ordinance as it currently is.

B. Pinkerton Rd Handicap ramp locations – Nissley provided suggested locations for handicap ramps on the east side of Pinkerton Road at Locust Lane and at Richland Lane. The Committee members will review and respond to Nissley with their preferences.

4. Compost Site - Nissley reported that the gates and fences are progressing and the key fobs should be operational in December.
5. Budget – The Committee lowered the budget amount for 435.600 Reconstruction of Sidewalk and Crosswalks from \$50,000 to \$25,000, and the transfer to Capital 492.100 Streets and Bridges from \$200,000 to \$175,000

6. Grants update
