## **CALL TO ORDER**

Meeting called to order by Councilor Reese at 1831 Hrs.

## **ROLL CALL**

Sam Sulkosky reported that research is being done to replace the street lights throughout the Borough with more efficient LED lights. Currently, 453 lights are eligible to be replaced. He will also be looking into grant money that may be available for this project.
