- **IV. ITEMS OF BUSINESS** 
  - 1. Parks
    - A. Park Rules The park rules were reviewed with new items added. Deering asked if fishing is considered wildlife in item #9. Suggested to add #17 to allow fishing with a proper license. Deering also asked to have the phrase "without written permission of the Borough" removed from specific items and one blanket statement added at the end. The rules are to be sent to Public Safety Committee for their review.
    - B. Church of God request for Memorial Park The Committee discussed the Church of God request and was not in favor of moving this to Council as proposed but will support this activity at any other park in the borough.
  - 2. Stormwater
    - A. NFWF Grant Salley reported on the status of the NFWF planning grant for streambank restoration.
  - 3. Streets and Alleys
    - A. Street Project updates Nissley reported on numerous street projects that are in the planning stages and current projects for 2021.
  - 4. Grants update
    - A. DEP 902 Grant Nissley reported that final reimbursement for the 2019 grant is expected soon. And DEP has opened a new grant round for 2021 has a September 24, 2021 deadline for application.
