On Tuesday November 15<sup>th</sup>, 2016, Officer Keiffer of the Mount Joy Borough Police Department, was dispatched to the Giant store located at 789 East Main St for a shoplifter in progress. While in route to the call Officer Keiffer was advised by Lancaster County Communications Dispatchers that the Retail Theft Suspect (Carrerra) was known to be armed and should be considered dangerous. The Dispatchers added that Carrerra was accompanied by a second suspect, Lisa Dawn Smith, and that they were operating a stolen dark gray 2006 Dodge Durango SUV.

Prior to Officer Keiffer arriving at the Giant, the suspects exited the store and entered the stolen Dodge Durango and exited the parking lot toward E Main St (RT 230). Officer Keiffer, who was assisted by Officer Kauffman of the Susquehanna Regional Police Department, attempted to conduct a traffic stop on the Durango, however, Carrerra refused to yield and fled from the Officers eastbound on E Main St (RT 230).

Over the next ten minutes, Carrerra led Officers on a pursuit on RT 230, RT 283, Rt 772 and N Colebrook Rd, at times with speeds approaching 100 MPH. Carrerra began to travel in the oncoming traffic lane at high speed on N Colebrook Rd and Officers fearing for the safety of motorists in the area, terminated the pursuit for safety reasons.

Officer Keiffer was assisted by Officers from Susquehanna Regional Police Department, Manheim Borough Police Department, and Northwest Regional Police Department as well as additional Officers of the Mount Joy Borough Police Department.


Information has been received indicating that Carrerra has been involved in similar Retail Theft incidents in at least two other Central Pennsylvania Counties, and had also been involved in at least two other high speed pursuits within the past two weeks.

Carrerra and Smith were last known to be traveling in a stolen 2006 Dodge Durango SUV, dark gray in color, taken in a carjacking in Middletown, Dauphin County, this past weekend. Both Carrerra and Smith should be considered armed and dangerous. The public is advised not to approach either subject if seen. Please dial 911 and report the sighting, or call Detective Hosking or Officer Keiffer of the Mount Joy Borough Police Department at (717) 653-1650.

UPDATE: Both suspects were apprehended in Dauphin County overnight November  $16^{\rm th}$  –  $17^{\rm th}$  following a pursuit. Carrerra crashed his vehicle during the pursuit and both he and Smith fled on foot. Both were taken into custody and they were taken to a local hospital for evaluation. They are expected to be committed to Dauphin County Prison on numerous charges.
