Myanmar Ambassador Visits Mount Joy By Chelsea Peifer

On March II and I2, the recently appointed Ambassador of the Republic of the Union of Myanmar, formerly known as Burma, paid a visit to Lancaster County, U Aung Lynn; his wife, Kay Thi; and two staff members traveled to Lancaster city, Gordonville, and Mount Joy, where they were hosted by Mount Joy mayor Tim Bradley.

Bradley noted that Myanmar has experienced significant governmental change since 2010 and is now a young, emerging democracy with newly restored diplomatic relations. Aung Lynn was appointed to be the new Myanmar ambassador to the United States in July 2016. Prior to that, he served as the permanent secretary of Myanmar's Ministry of Foreign Affairs and as director general of the ministry's ASEAN Affairs Department, according to http://www.cogitasia.com.

and the agricultural economy of the region. "The big thing for him was to see Main Street America and to understand how people live and work." Bradley said. "We tried to give him a sampling of what life is like here."

Bradley was identified as a potential delegation contact and escort following his selection and participation in a multiple international political exchanges, the most recent as an American Council of Young Political Leaders (ACYPL) delegate to Japan in December 2016. The ambassador had also been interested in visiting the area since his daughter graduated from Franklin & Marshall College.

Aung Lynn had the chance to explore Central Market in downtown Lancaster before being shuttled to Gordonville to experience the community's annual spring mud sale and auction. Next, Aung Lynn met Bradley in Mount Joy for a tour of Fire Department Mount Joy and to discuss volunteerism and local governance.

Bradley then escorted the ambassador's delegation to Brubaker Farms in Mount Joy, where owner and operator Luke Brubaker discussed environmentally sound agricultural practices and provided a tour of the facilities. The whirlwind day concluded with a historical tour of a Mount Joy brewery.

On March 12, the ambassador's delegation attended a service at LCBC church in Manheim. Bradley said the service gave the delegation a look at an American evangelical church in order to better understand the facets of Christianity and American nondenominationalism.

"I believe he has been the first ambassador from overseas to visit our community," said Bradley. "He said that he really enjoyed his time here."

Bradley noted that prior to returning to Washington, D.C., the ambassador expressed interest in discussing options for bringing political and business leaders to the region in the future for further dialogue with the local business and agricultural communities. UPDATES

- American Legion-540 Clay Alley. Finalized review of Highway Occupancy Plan (HOP), HOP Agreement, and received Borough Engineer recommendation for financial security. Received and reviewed draft Stormwater Management Agreement from Borough Solicitor. The Land Development Plan was previously approved, but not recorded. Once Agreements are executed and financial security received, the plan can be executed and recorded.
- Old Standby Park- Attended pre-construction meeting with PPL, UGI and staff on March 29th.
- Rail Enhancement Project- Received copy of Communications Plan from Borough Manager on March 22nd. Met with Project Manager and Borough Manager to briefly discuss Communications Plan.
- Phone conference with Borough Engineer regarding the Rotary Park trail and sidewalk connection. Reviewed revised sidewalk connection plan from DC Gohn. Reviewed comments from Borough Engineer relating to the Rotary Park sidewalk and path extension. Dennis has executed the Highway Occupancy Permit (HOP) and DC Gohn has submitted the application and plans to PennDOT for review and approval.

REPORT

- Snow inspections started Thursday, March 23, 2017.
- Attended staff meeting.
- Attended Borough Council meeting.
- Reviewed Request by Turkey Hill, 703 E. Main Street for approval of an inter-municipal transfer of restaurant liquor license. Reviewed zoning for additional use requirements. Reviewed Borough Solicitor email on proposal and zoning interpretation.
- Read and reviewed 20-page document from Robert F. Powelson, Commissioner of Public Utility Commission, addressing the relevant role of the Commission under applicable PA and federal law over distributed antennae system (DAS) facilities and other attendant issues related to DAS networks. Reviewed Borough Solicitor response on this matter.
- Met with Charter Homes, Desmond Management and Staff to discuss future of Florin Hill. Met with same group onsite on March 20th to discuss possible solutions for partial street dedication.
- Dennis Nissley and I met with Carey Seyler, Right-of-Way Agent on behalf of the Atlantic Sunrise Pipeline Project, at Patrick Industries, 20 Eby Chiques Road. The plan indicates an approved access road on this property for staging of materials during the project. Discussion included location of entrance, permits, clear site concerns, and Road Use Agreement to be drafted by the Borough Solicitor.
- Assisted with rental inspections.
- Continued upkeep of the rental inspection program, i.e. issuing licenses, maintaining current inspections.
- Reviewed the three (3) grant applications from ARRO Engineering on behalf of the Borough, for the Urban Stormwater Best Management Practices (BMP) Projects through the Department of Environmental Protection (DEP). Provided several comments and corrections on each. Three (3) grants were submitted on March 1st for locations at Rotary Park, Pink Alley and The Lakes at Donegal Springs.

- Received and reviewed the As-Built Plans for the Farmview Development. Forwarded As-Built Plans to ARRO Engineering for review and recommendation of release of portions of the Financial Security as requested by the Developer. Reviewed Borough Engineer letter of recommendation.
- Mailed approximately 200 late rental license letters with invoices.
- Met with Scott Cagno, at 30 S. Jacob Street for a walk through of the building with his contractors. Mr. Cagno will be the new owner of this building. Tyco is still occupying and operating out of the building for now until roughly October 2017. However, in the near future, Mr. Cagno will be operating his business, NEI -The Envelope Specialist. NEI conducts off-set printing for customers and their proposed jobs, i.e. envelope printing, and warehousing.
- Attended walk-through of the old movie theater building at 63-67 W. Main Street (rear) with the Economic Development Company (EDC), MSMJ and others on March 23rd.
- Met with Mount Joy Township Manager to highlight some items on the Permit Software. The Township is considering purchasing the software.
- Participated in Webinar presented by the Chesapeake Bay Stormwater Network - Planners and implementers are always looking for new ways to earn credit towards reducing nutrient and sediment loads. This webinar looked at two new approaches that have been recently approved by the Chesapeake Bay Program Partnership. The Impervious Cover Disconnections to Amended Soils BMP Expert Panel was convened in 2015 to assess the nutrient and sediment reductions that can be achieved by directing or otherwise spreading stormwater from impervious cover of existing development (not new or re-development) to an acceptable area of pervious cover where it may be effectively stored and infiltrated into the soil. Continuous Monitoring and Adaptive Control (CMAC) technologies are a BMP enhancement to stormwater facilities that directly monitor performance and make automated and predictive control decisions to actively manage stormwater storage and flows.
