

**Mount Joy Borough Parks Advisory
Board – Little Chiques Park Master Plan

- 1) Call to Order – 630 pm
- 2) Roll Call— Christian, Morrison, Geltmacher, Miller, Deering, Zevallos
- 3) Consider a motion to approve the February 11, 2025, Meeting Agenda. - Motion by Christian 2nd by Miller, motion approved
- 4) Public Input Period - Comments of Any Borough Resident or Borough Property Owner. Time limit of three minutes will be strictly enforced. - None
- 5) Approval of Minutes from January 14, 2025 -Motion by Christian 2nd by Deering, motion approved
- 6) YSM Consultant – Ann Yost/Chuck Strodoski
 - a) General updates – Yost spoke about their cost opinion of the park and recommended doing the project in phases. The board discussed possible walking / bike trail and steps for disc golf hole #1 as phase one, phase 2 Bathrooms, walking only trail through the park, phase 3 tot lot, youth playground 25% of parking lot, all were just possibilities.
 - b) Plan update
 - c) Project costs & Maintenance costs. - Cost opinion cost \$3,305,239. Yearly maintenance costs \$10,500
 - d) Financing the project. - We as a Borough will apply for a grant of \$200,000 with a match from the Borough of \$200,000 for a total of \$400,000
- 7) Update on Streambank Restoration Project – Construction is ongoing, and phase 2 was awarded to Flyway Construction
- 8) Updates on Pickleball Courts – Pickle Ball courts were presented to Public Works Committee, and Kunkle Field (Borough Park) is the park to be considered, it will now go to full council
- 9) Any other matter. – Zevallos asked if there were any comments from YMS's presentation at council meeting, Christian replied they loved it. We talked about other funding that may be available from other grants or organizations. Also discussed how we could get the parking lot paved or at least the base coat installed. It was questioned if this board was only for the master plan of Little Chiques Park or would we remain a board for all parks?
