Motion was made to eliminate Navarro & Wright by Morrison 2nd Zeyallos motion approved. After a lengthy discussion between YSM and JMT and a recommendation from Rettew for YSM, a motion was made by Geltmacher 2nd by Deering to present YSM to Borough council for approval.
- 8) Update on grant funding for Streambank Restoration Project. Pugliese gave an update, Rettew is moving forward with the RFP and bid documents, we are not sure where the project will start at this time. The borough manager is also applying for other grants.
- 9) Update Chiques Crossing. Christian gave update stating that Chiques Crossing withdrew their plans at this time, and there is a group that hired a consulting firm to survey flood plans.
- 10) Any other matter. Geltmacher reported that Chiques Creek Watershed Alliance would like to do a creek stomp at Little Chiques Park in August with the help of Lancaster County Conservation District.
