

**Mount Joy Borough Parks Advisory Board – Little  
Chiques Park Master Plan Minutes  
6:30 PM, Tuesday, May 14, 2024**

- 1) Call to Order – 06:33 pm
- 2) Roll Call— Christian, Morrison, Geltmacher, Miller, Deering, Zevallos
- 3) Consider a motion to approve the May 14, 2024, Meeting Agenda. - Motion by Zevallos 2<sup>nd</sup> by Deering motion approved
- 4) Public Input Period - Comments of Any Borough Resident or Property Owner. Time limit of three minutes will be strictly enforced. - none
- 5) Approval of Minutes from April 9, 2024.- Motion by Zevallos 2<sup>nd</sup> by Christian motion approved.
- 6) Discuss public survey. – As of May 14, 2024, we had 118 responses to our survey with the 31 – 45 age group being the most responses, 14 responders indicated they would like to be more involved. Miller will make the survey available at Donegal schools. The board also talked about advertising our survey in our local Merchandiser.
- 7) Update on Consulting Firm to be awarded the Streambank Restoration Project. – Geltmacher gave the Borough Manager report, council approved awarding the contract to YSM as the consultant. The grant requires the state to approve it. He has forwarded the required documents to DCNR and is awaiting approval.
- 8) Update on grant funding for Streambank Restoration Project –
  - a) We have a \$1.7 mil grant that we applied for through NFWF and a \$300,000 grant through DCED for the streambank restoration.
  - b) The Borough is working with the Mannings, property owner along the creek, and Rettew to have their property lines surveyed.
  - c) The Borough Manager is working with Borough Solicitor on updating agreement documents.
- 9) Update Chiques Crossing. – Christian said there was nothing on their agenda at this time (Rapho Twp.), Manager’s report stated no updates other than they are working on a smaller footprint.
- 10) Any other matter. - Christian said that he attended Rapho Twp. Comprehensive Plan meeting, also there was discussion on surveying the Manning property
- 11) Public Input Period - Comments of Any Borough Resident or Property Owner. Time limit of three minutes strictly enforced. - None
- 12) Adjourn. – Motion by Miller 2<sup>nd</sup> by Christian, motion approved. 7:40 pm
