Public Works Committee Meeting Minutes for January 11, 2021

Councilor Deering called the meeting to order at 6:30 PM.

- I. APPROVAL OF JANUARY 11, 2021 PUBLIC WORKS MEETING AGENDA -Approved
- II. HEARING OF ANY CITIZEN CONCERNS Time limit of three minutes per individual. None
- III. APPROVAL OF MINUTES from the December 14, 2020 meeting Approved
- IV. ITEMS OF BUSINESS
 - 1. Parks
 - A. Old Standby Park Kiwanis MOU renewal Nissley reported that the Kiwanis Club members will be responsible for trimming plants that are approximately 3 feet tall and under.
 - B. Memorial Park Gazebo Nissley reported on maintenance items that will be addressed by staff. This will include repair of some wood that has been chewed by squirrels. Cleaning and staining the siding and wood trims. Staff will get cost estimates for repair or replacement of the lights in the ceiling, and the roof shingles. Bait stations will be placed in the storage area to address an apparent mouse problem.

2. Stormwater

- A. Stormwater pipe replacement on SR 772 Salley reported on the need to replace stormwater pipes along SR 772 prior to PennDOT repaying the road. Staff will contact ARRO to prepare a cost estimate for this work.
- 3. Streets and Alleys

- A. PennDOT 772 Resurfacing Nissley reported that PennDOT has informed the borough of plans to repave SR772 in the borough in late 2021 or 2022. The sidewalks and curbs have been surveyed, and letters have been sent out to property owners that need to do repairs.
- B. Review 5 year street plan Nissley presented an updated Tentative 5 year Street and Alley Plan. The Committee reviewed the plan and agreed that it should be posted on the Borough website. Mayor Bradley inquired about a handicap ramp on an alley along Marietta Ave.

4. Grants update

- A. DEP 902 Nissley gave an update on the leaf truck which is still in production. Nissley also reported that the current 902 grant has been suspended for new applications.
- 5. Marietta Avenue Paving and Pedestrian Project Nissley reported that the sidewalks are completed and there are a few private walks that still need to be installed to connect to the sidewalks.
