- 1) Call to Order
- 2) Roll Call— Christian, Geltmacher, Deering, Zevallos
- 3) Consider a motion to approve October 14, 2025, Meeting Agenda. - Motion by Deering, 2<sup>nd</sup> by Zevallos, motion approved.
- 4) Public Input Period - Comments of Any Borough Resident or Borough Property Owner. Time limit of three minutes will be strictly enforced. - None.
- 5) Approval of Minutes from September 9, 2025 – Motion by Deering, 2<sup>nd</sup> Zevallos, motion approved.
- 6) Updates on Master Site Development Plan – Plan is finished, and the grant was satisfied, and all requirements have been met.
- 7) Update on Streambank Restoration Project – Phase III is out to bid; the bid also has an alternate bid to add large rocks where the creek flooded in July in hopes to reduce sediment coming into the park area. Christian commented on how good a job Flyway Const. did.
- 8) Malmedy Memorial – Rotary Club, Christian stated that the project is to cost around \$37,000.00, they are going to sell pavers with veteran's names on them as fund raiser for the project, there was discussion on whether the paver sponsor would have their name on the paver along with the name of the veterans.

Zevallos said she is mapping out a possible nine-hole disc golf course between Rotary Park and Cove Outlook Park. We talked about an Adopt a Park program where maybe an organization would help upkeep a park (Kiwanis club used to do Old Stand By Park)
- 13) Adjourn (adjourn from Lakes Park) - Motion by Deering 2<sup>nd</sup> by Zevallos motion approved 8:05 pm.
