- 1) Call to Order – 6:30 pm
- 2) Roll Call— Christian, Geltmacher, Deering, Zevallos
- 3) Consider a motion to approve December 9, 2025, Meeting Agenda. - Motion by Deering to amend the agenda to add park inventory as item 9a. Motion to approve the agenda as amended by Deering 2nd Zevallos motion approved
- 4) Public Input Period - Comments of Any Borough Resident or Borough Property Owner. Time limit of three minutes will be strictly enforced. - None
- 5) Approval of Minutes from October 14, 2025 – Motion by Deering 2nd by Zevallos, motion approved
- 6) Election of Officers

- 7) Update – Master Site Plan C2P2 Grant – Our grant has be closed. We talked about planning with future grant money. Deering asked about how many hard copies we got from YSM, Geltmacher said he would check with the manager
- 8) Update on Streambank Restoration Project – Conversation was had on who was awarded phase III. Zevallos asked if some of the trees planted could be moved so as not to interfere with the disc golf course
- 9) Discussion and Motion regarding ADA Priority to two fishing platforms at Little Chiques Park – It decided to recommend posting signs on the to closest piers to the parking lot with signage stating, (This ramp and fishing platform meet the standards of the ADA and may be used by anyone. Please respect the desire of people with disabilities to fish on the fishing platform.) this verbiage was endorsed by US Fish & Wildlife Service (Dept. Of The Interior) and US Forest Service (Dept. Agriculture). A motion was made by Christian and 2nd by Geltmacher to recommend this signage to Public Works committee, Motion was approved
 - a) Park Inventory (Amendment request by Deering – Christian, Geltmacher, Deering and Zevallos voting in favor of the amendment. Morrison absent) – The board expressed interest in having all parks inventory be put on a spread sheet.
