The Mount Joy Borough Zoning Hearing Board met in the Council Chambers of the Mount Joy Borough Offices, 21 E Main St, Mount Joy, PA 17552 on the above Hearing Date. The hearing was called to order by Chairperson Robert Marker, present members were George Leyh, Mike Melhorn, Thomas Paul, absent was Ned Sterling. Present was Borough Zoning Officer, Duane Brady Jr; Zoning Hearing Board Solicitor, Joseph Kenneff; and stenographer Michelle Parke.

- 3. Zoning Ofc Brady sworn in and reviews application and pre-hearing procedures of Case 23-05 with ZHB Solicitor Kenneff at 7:05pm
- 4. Applicant Luke Wayman was allowed to ask questions of Zoning Ofc Brady regarding the case history
- 5. Luke and Catherine Wayman sworn in to give testimony to the application at 7:16pm
- 6. Mr. & Mrs. Wayman testify that they currently have 5 ducks on the property in question and provide further testimony for the application.

- 14. ZHB Solicitor Kenneff asks Mr. and Mrs. Wayman if they would like to modify their application to receive a special exception, applicants agree
- 15. Thomas Paul presents motion, 2nd by George Leyh to approve the special exception for a maximum of 2 ducks and that the applicant has 6 months to reduce the 5 ducks to 2 ducks, members vote 4-0 in favor to grant
- 16. Case 23-05 closed at 7:56pm
- 17. Case 23-06 called to order at 7:57pm
- 18. Zoning Ofc Brady is questioned about the case
- 19. Applicant Alan Nelson of CRATR Properties sworn into give testimony at 7:58pm
- 20. Zoning Officer Brady gives additional testimony on the case facts and history
- 21. David & Brenda Glasford of 334 Chocolate Ave sworn in to give testimony against the application at 8:03pm
- 22. Leon Gehman of Chiquesville LLC present as a neighbor and makes an unsworn statement directed by ZHB Solicitor Kenneff
