Organization-

- 1) MSMJ manager attended manager meeting in Harrisburg Feb. 15
- 2) Audit has been finished and report is being prepared for the Board of directors in March.
- 3) MSMJ will be hosting several targeted meeting for businesses. The first one will be creating daytime traffic to the down town. These meetings will be hosted by MSMJ to help create a think tank of ideas and pilot programs. The businesses will ultimately decide which ideas they would like to do.
- 4) MSMJ volunteers will be helping to clean out 93 E. Main for a yard sale to benefit MSMJ. Project will be handled and organized by Tena Hoffer. She will need volunteers to help bring items down on March 7 starting at 9am. You can reach her at 653-4665.
- 5) MSMJ is planning to send their executive Director to Pittsburgh for the National Conference.

Economic Development -

- MSMJ will be hosting several meetings to help establish some new businesses and implement some changes to some anchor businesses in the downtown. We will be learning the process to apply for USDA grants. Mount Joy has been added to the list of eligible candidates for these grants.
- 2) We are still awaiting approval of two leases on 2 new businesses.

were featured and 13 wines or beers.

Design-

- 1) Design committee has committed to drawing down all grant funds by June 2017.
- 2) I have reached out to the EDC to give some available dates and times for them to come and tour the Theater Building. The walk thru will take place in March.Dates are pending.
- 3) Banner program- VFW and the Design Committee will meet on March 1st to discuss a cooperative effort on the spring banners; "Salute to Hometown Heroes".
- 4) Flower planters are in need of sanding and staining before planting this summer. Work dates, times, and crews we will start the work as soon as possible. Volunteers are needed.

Promotions-

- 1) Car show information for street closing has been sent to Chief Williams and Manager Sulkosky.
- 2) Parade Auction will be held on April 1, 2017. MSMJ has had several new bands and contacts for this year's parade. Flier will accompany this report.
- 3) The promotions committee had a goal of selling 200 chocolate tour tickets we sold over 400.
- 4) We will have 2 more walking tours this summer.
- 5) Information will go out for Balloon Sponsors for splash in March.

Other Business – Grant opportunity for crosswalk improvement money will become available through the CFA Multimodal Transportation Fund. The window for this will open at the end of March and close in July.



RE: Stormwater Management Report for February, 2017

Stormwater Management:

<u>-DEP Grant Applications-</u> Nate Merkel (ARRO), Dennis, Stacie, and myself have been exploring areas around the Borough to implement retrofitting existing BMP's (Best Management Practices). We have submitted three applications for three separate projects which would significantly reduce our pollutant load and meet our required goals for the Chiques Creek Watershed and the Unnamed Tributary to Donegal Creek Watershed. The three areas of these retrofit projects are Rotary Park Swale, Pink Alley Detention Basin, and The Lakes at Donegal Springs HOA swale. Attached is a letter to proceed with the grant application from The Lakes HOA explaining what type of project would be in place.

-Church Street thru Pink Alley Pipe Replacement Project- Jim Messersmith from Public Works and myself went to investigate issues with existing stormwater pipes and structures along Church St. Upon our investigation we found that the existing corrugated metal pipes are showing signs of corrosion and existing inlet structures are deteriorating. A plan is in place to resolve these issues in 2017. The first part of the project will be to replace existing pipes that fall in an existing stormwater easement between Church St and Pink Alley. The two areas where the replacement of pipes will be are between 580 and 576 Church St properties (200') & 552 and 556 Church St properties (140'). The second part of the project will be replacing an existing inlet structure on the corner of Church St and Green Alley, equipping inlet structures with bicycle safe grates, and replacing existing corrugated metal pipes (80'). All stormwater pipes will be replaced with smooth lined corrugated plastic pipe. The first part of the project is to start at the beginning of April. The final part of the project will begin towards the end of June.
