PER MOUNT JOY BOROUGH ORDINANCE 195 SECTION 904.1 - PROPERTY OWNERS THAT DO NOT LIVE WITHIN LANCASTER COUNTY ARE REQUIRED TO APPOINT A PROPERTY MANAGER. THE APPOINTED PROPERTY MANAGER SHALL RESIDE OR WORK IN LANCASTER COUNTY. WHEN A PROPERTY OWNER APPOINTS OR CHANGES A PROPERTY MANAGER (REGARDSLESS OF IF THE APPOINTMENT IS REQUIRED BY ORDINANCE OR NOT) THE PROPERTY OWNER SHALL REPORT SUCH APPOINTMENT OR CHANGE WITHIN 30 DAYS. FAILURE TO COMPLETE AND SUBMIT THIS REPORT WITHIN THE 30 DAYS OF A CHANGE OF TENANT SHALL CONSTITUTE A VIOLATION OF THE ORDINANCE AND COULD RESULT IN ENFORCEMENT ACTION. THE FOLLOWING INFORMATION SHALL BE PROVIDED ON THIS FORM WHEN REPORTING AN APPOINTMENT OR CHANGE OF MANAGER: COMPANY NAME (IF APLLICABLE), NAME OF AGENT/MANAGER, OFFICE PHONE, DIRECT PHONE, EMAIL, PHYSICAL/MAILING ADDRESS (A PO BOX IS NOT AN ACCEPTABLE MAILING ADDRESS, INCLUDING UPS STORE OR SIMILAR PO BOXES), AND DATE OF APPOINTMENT.
