

**Mount Joy Borough Parks Advisory  
Board – Little Chiques Park Master Plan

6:30 PM, Tuesday, July 8, 2025**

- 1) Call to Order – 6:30 pm
- 2) Roll Call— Christian, Deering, Geltmacher, Zevallos
- 3) Consider a motion to approve July 8, 2025, Meeting Agenda. – Motion by Deering 2<sup>nd</sup> by Zevallos motion approved
- 4) Public Input Period - Comments of Any Borough Resident or Borough Property Owner. Time limit of three minutes will be strictly enforced. - None
- 5) Approval of Minutes of June 10, 2025 – Motion by Zevallos 2<sup>nd</sup> by Deering motion approved
- 6) Updates on Master Site Development Plan – Rachel is pursuing grants for LC Park
- 7) Update on Streambank Restoration Project – Discussion on the flooding that took place in the park, we had offers from organization to help with clean up. Flyway Cont. is still working on phase 2 of the project
- 8) Review recommendations from Park Inventory on June 10, 2025 – Christian compiled information on our park's deeds and acreage of 72.31 acres, DCNR recommends 10 acres per 1,000 population
  - a) Little Chiques Park – Morrison did an inventory of the parks we visited.
    - i) Recommendation for 2 ADA Priority Fishing Piers to be submitted to Public Works Committee. – Board decided to wait until design was complete before recommending which pier or piers would be recommended for ADA Priority Fishing Piers, also there was discussion on signage for piers that we would recommend for ADA, and Christian offered to look at what other municipalities use for signage. Discussion on possibly moving a couple of trees that may block our disc golf course in the future, we thought it might be best if we waited until our grant closes.
  - b) Borough Park/Kunkle Field – Discussion was had on some of the neighbors' issues due to baseball.
- 9) Public Input Period - Comments of Any Borough Resident or Borough Property Owner. Time limit of three minutes will be strictly enforced. - None
- 10) Any other matter. – Geltmacher reported the Lakes Park tennis court had pickleball court lines painted professionally (2 courts) at no cost to the Borough, and we would look into portable nets. Christian reported Chiques Crossing (Vista Block) development is looking at possibly crossing under the creek at Pine St. with a sewer line
