

**Mount Joy Borough Parks Advisory

- 1) Call to Order – 6:32 pm
- 2) Roll Call— Christian, Morrison, Geltmacher, Deering, Zevallos – Manager Mark Pugliese
- 3) Consider a motion to approve September 9, 2025, Meeting Agenda. – Motion by Geltmacher 2<sup>nd</sup> Christian motion approved.
- 4) Public Input Period - Comments of Any Borough Resident or Borough Property Owner. Time limit of three minutes will be strictly enforced. - None
- 5) Approval of Minutes from July 8, 2025 – Motion by Christian 2<sup>nd</sup> by Deering motion approved.
- 6) Updates on Master Site Development Plan – Council approved the master plan for Little Chiques Park submitted by YMS, and we are to receive two hard copies and one digital copy from them. Manager stated we have \$100,000 from this year and \$100,000 for next year and that we are applying for a grant for \$200,00 for a total of \$400,000 to start work from the master plan next year
- 7) Update on Streambank Restoration Project – Flyway const. finished Phase II, and on Sept. 18<sup>th</sup> we will have a walk through. Phase III from the park to RT. 230 must be completed by March 31<sup>st</sup>, 2026. We have a grant through Clean Water Partners for Phase III
- 8) Malmedy Memorial – Rotary Club, Council approved the verbiage for a plaque, Christian said the cost estimate was around \$20,000
- 9) Park Inventory – Visit parks – We visited all three parks; there was discussion on the amenities each park offered and what other amenities could be offered in the future.
  - a) Rotary Park
  - b) Grandview Park
  - c) Old Standby Park
- 10) Public Input Period –(At Old Standby Park) Comments of Any Borough Resident or Borough Property Owner. Time limit of three minutes will be strictly enforced. – None
- 11) Any other matter. Geltmacher mentioned an (Adopt a Park program) to see if any local organizations would be interested in helping with the beautification of one of our small parks
- 12) Adjourn (adjourn from Old Standby Park) – 8:00pm Motion by Christian 2<sup>nd</sup> by Geltmacher, motion approved
