Minutes

The Mount Joy Borough Authority held its Pre-Authority meeting on this date in Council Chambers of the Borough Offices Building and via online zoom. Chairman Rebman called the meeting to order at 4 PM.

Public Input Period

No one from the public was present.

Consulting Engineer Report

Mr. Dennis was not present at the meeting, therefore, provided a written report.

Authority Manager Report

Mr. Ardini provided a written report and highlighted the following:

Mr. Ardini provided an update on refinancing the two sewer notes and possible one water note: Mr. Ardini stated RBC Capital have been receiving questions from lenders of which the Authority staff have been prompting answering in return. Mr. Ardini stated this is hopeful for great savings and shows that there is interest in the market. Mr. Ardini reminded the Board that the Borough Administration and Finance Committee is slated for April 22nd.

Mr. Ardini provided an update on the Water Resource Plan for Well #3: SRBC has received, reviewed, and supplied the Authority with a confirmation letter stating the plan is consistent and sufficient to meet the requirements within the docket.

Mr. Ardini informed the Board that a meeting is scheduled for April 26th to discuss the Well 3 action plan.

Mr. Ardini noted that staff continues to work on the annual Consumer Confidence Report.

Operations Manager Report

Mr. Kapcsos provided a written report and highlighted the following:

Mr. Kapcsos provided an update on the EPA Risk and Resilience Assessment: Mr. Kapcsos stated that staff is meeting with ARRO and 12:34 MicroTechnologies tomorrow to discuss the IT measures in place.

Mr. Kapcsos informed the Board that staff did start up South Jacob Street water plant last week and has recently went offline due to low creek levels.
