

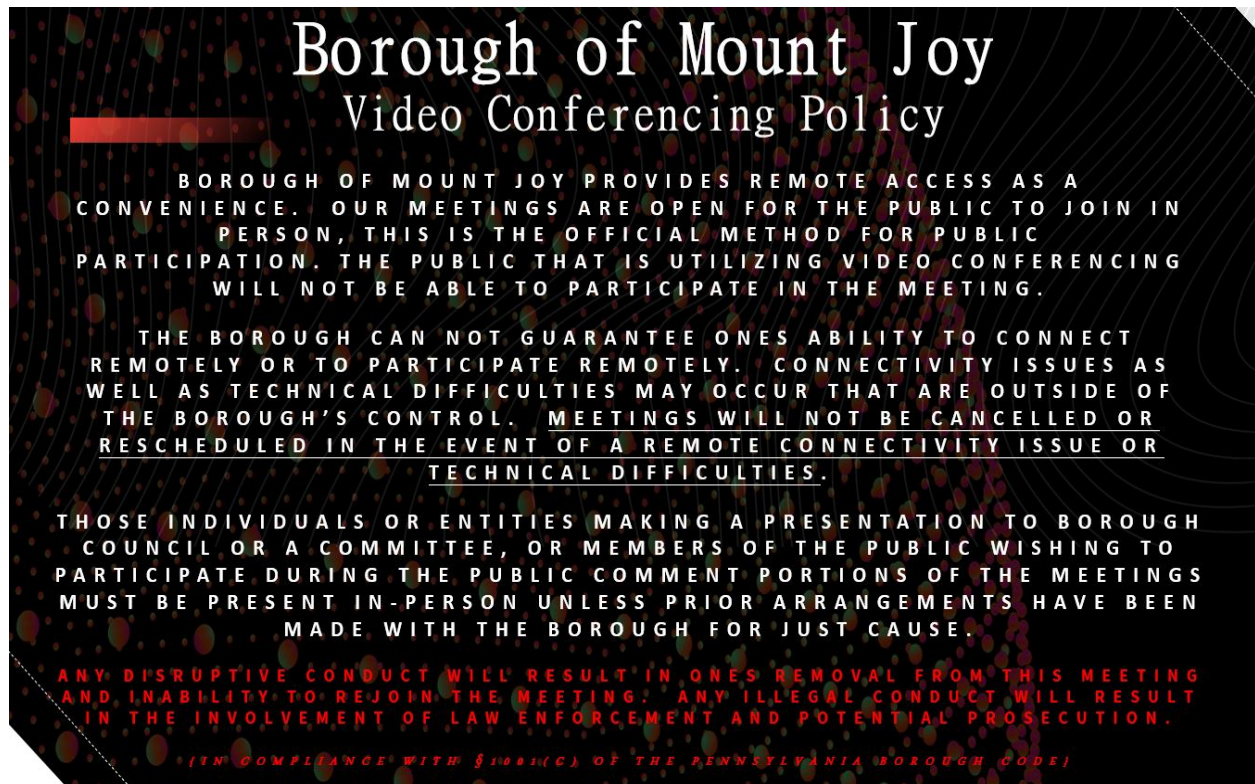

BOROUGH OF MOUNT JOY PROVIDES REMOTE ACCESS AS A CONVENIENCE. OUR MEETINGS ARE OPEN FOR THE PUBLIC TO JOIN IN PERSON, THIS IS THE OFFICIAL METHOD FOR PUBLIC PARTICIPATION. THE PUBLIC THAT IS UTILIZING VIDEO CONFERENCING WILL NOT BE ABLE TO PARTICIPATE IN THE MEETING.

THE BOROUGH CAN NOT GUARANTEE ONES ABILITY TO CONNECT REMOTELY OR TO PARTICIPATE REMOTELY. CONNECTIVITY ISSUES AS WELL AS TECHNICAL DIFFICULTIES MAY OCCUR THAT ARE OUTSIDE OF THE BOROUGH'S CONTROL. MEETINGS WILL NOT BE CANCELLED OR RESCHEDULED IN THE EVENT OF A REMOTE CONNECTIVITY ISSUE OR TECHNICAL DIFFICULTIES.

THOSE INDIVIDUALS OR ENTITIES MAKING A PRESENTATION TO BOROUGH COUNCIL OR A COMMITTEE, OR MEMBERS OF THE PUBLIC WISHING TO PARTICIPATE DURING THE PUBLIC COMMENT PORTIONS OF THE MEETINGS MUST BE PRESENT IN-PERSON UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE WITH THE BOROUGH FOR JUST CAUSE.

ANY DISRUPTIVE CONDUCT WILL RESULT IN ONES REMOVAL FROM THIS MEETING AND INABILITY TO REJOIN THE MEETING. ANY ILLEGAL CONDUCT WILL RESULT IN THE INVOLVEMENT OF LAW ENFORCEMENT AND POTENTIAL PROSECUTION.
