# **SVEMS REPORT**

There was a total of sixty five calls in the Borough; fifty three were covered by SVEMS. Captain Marsden, Operations Manager with SVEMS spoke of the cardiac arrest that occurred at Giant Foods on September 5, 2019 which had a successful outcome. There will be a Save Ceremony at Giant Foods on October 5, 2019 at 11am and the Fire Department, EMS, Police Department and the bystanders that assisted that day are
